- 4 Design a repeat pattern based on the theme **Tea Time**.
- 5 Design a costume for a theatrical production called **Plugged In**.
- 6 Design a bag or backpack for a fashion collection called **Paraphernalia**.
- 7 Produce a carpet or rug design based on the theme **Neighbourhood**.
- 8 Design a children's playground based on the theme **Jungle**. Consider the materials for construction and include an illustration and a ground plan of the area.
